Dear Applicant:

We welcome your decision to apply for a TMC Technician Scholarship. ATA's Technology & Maintenance Council (TMC) is a membership of fleets, equipment suppliers, educators, and service providers, that create Recommended Maintenance and Engineering Practices for the trucking industry. Please take a few minutes to review the guidelines below before beginning the application. With this application, you are applying for the Lincoln Technical Institute/Lincoln College of Technology/Nashville Auto Diesel College. A total of four (4) one-half scholarships are available as detailed below.

YOU are the one responsible for assuring the application is completed and submitted on time. Completed scholarship application packages must be received by the TMC office by April 15, 2023. This is a tremendous opportunity to further your education through your own efforts with a small investment of your time. Winners will be notified by May 15, 2023.

**Guidelines - Please read carefully before completing application**

1. To be considered for a TMC scholarship:
  - a. You must have a sponsor who is a current dues-paying TMC member, or is employed/contracted by a company with at least one current dues-paying TMC member.
  - b. Your application must be accompanied by a letter of recommendation from your sponsor.
2. You must be graduating from an accredited vocational, public, private, or parochial high school.
3. It is necessary for you or your high school counselor to send TMC your high school transcript showing your most recent three years' academic performance.
4. Return the completed application to your sponsoring TMC member representative. The TMC member representative should complete the section entitled "TMC Sponsor Data" and the entire package must be received by the TMC office by April 15, 2023. Awards will be announced by May 15, 2023.
5. Half-scholarship is awarded for a 1200-1560 hour program, depending on location, attendance to one of six Lincoln Technical Institute/Lincoln College of Technology in: Denver, CO; Indianapolis, IN; Nashville, TN; Grand Prairie, TX; E. Windsor, CT; S. Plainfield, NJ. Students may select from one of five class start dates: June 2023; July 2023; August 2023; September 2023; October 2023. Scholarship award to be used for tuition only.
6. Before the half-scholarship is actually awarded, TMC must verify your acceptance by Lincoln Technical Institute/Lincoln College of Technology-Nashville.
7. There are two sections of the application, one to be completed by you and your parent/guardian (if under 18) and one to be completed by the counselor at your school.
